

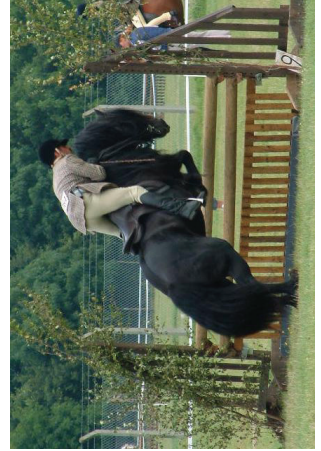


Privileges of Membership

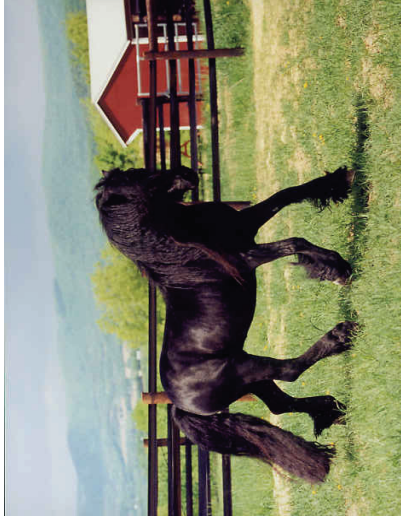
- Semi-annual FPSNA newsletter - "The Fell Pony Express".

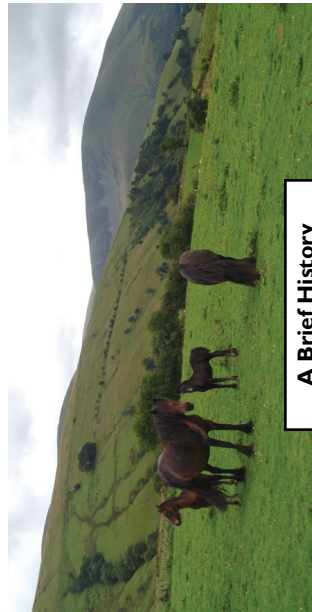

About FPSNA, Inc.

The Fell Pony Society of North America, Inc. (FPSNA), is federally-recognized as a public charity, effective January 2002, under Section 501(c)(3) of the Internal Revenue Code. FPSNA was established to promote and preserve the Fell Pony breed in North America. FPSNA was the first Registered Overseas Branch of the Fell Pony Society (UK) and is the oldest & largest Fell Pony organization in North America. Members of FPSNA are also encouraged to become dual members of FPS, the worldwide authority and registry for this rare native British pony breed. Currently there are about 250 Fell Ponies in North America and less than 6000 worldwide.



A Brief History

The Fell pony originated in the Lake District of northern England, where the "hills" are also called "fells". Local demands required an all-round family pony that was not only capable of carrying all members of the family, but also versatile enough to fulfill a wide variety of jobs. These included pack work, riding, driving, and other tasks suited for a small but strongly-built and sensible pony. In this capacity the Fell Pony was ideal, being well up to the weight of a heavy adult, yet quiet enough for a child.

The present day Fell Pony is able to meet modern demands with the same adaptability so endeared by Lakeland farmers. The Fell's fast walk and easy paces make it a pleasant and comfortable ride, and its surefootedness ensures a safe passage over the roughest country. Indeed, it is possible to ride a Fell Pony through places where other lighter-bred ponies would come to grief! The Fell is known for its kind and intelligent nature, and can make not only a wonderful driving pony but also a creditable jumper. All these attributes make the Fell Pony an ideal family pony.
